OMAHA, Neb. - Jan. 18, 2010 - Warren Buffett's preferred stock holdings in Berkshire Hathaway surged to \$14.8 billion, according to the latest filings on the company's 13D filings with the Securities and Exchange Commission. Buffett, the holding company's second-largest shareholder, owns roughly 24.8 million shares, or nearly 1.8 percent of the Class A and B shares. The rest of his holdings are made up of Berkshire stock and options. For 2001, Buffett has \$78 billion in Berkshire shares and stock options. His shares and options make up 2.1 percent of Berkshire, a 0.15 percent increase since last quarter. Buffett has owned Berkshire shares since early 1970, and in November, he said he intended to hold on to his Berkshire shares for the rest of his life. This quarter's filing includes a document dubbed, "the Plan of Incorporation for the Class A and Class B Shares of the Company," which provides information about the ownership structure of Berkshire's Class A and Class B shares. The filing also includes information on future transactions that could affect the ownership structure of Berkshire's Class A and B shares. 1. Warren E. Buffett owns a majority of the Class A and B shares of Berkshire Hathaway Inc. Class A and Class B shares make up the majority of the outstanding shares of the company. They are listed on the New York Stock Exchange.
2. Matthew A. Munger, the son of the company's chairman, owns stock representing the second largest interest in the company.
3. George E. Berkshire owns 1.01 percent of the company's Class A and B shares.
4. Thomas T. Lee, Jr. owns 0.78 percent of the company's Class A and B shares.
5. Lawrence T. Lorshown owns 0.58 percent of the company's Class A and B shares.
6. Larry G. Clausing owns 0.05 percent of the company's Class A and B shares.
7. Jean M. Buffett owns 0.01 percent of the company's Class A and B shares.
8. Charlie Munger, the company's vice chairman, owns 0.01 percent of the
